THE STATES COMMITTEES and STATES ENGINEER (TRANSFER OF FUNCTIONS) (ALDERNEY) ORDINANCE, 1999

THE STATES OF ALDERNEY, in exercise of the powers conferred upon them by section 1 of *The Public Functions (Transfer and Performance)* (Bailiwick of Guernsey) Law, 1991(a), and all other powers enabling them in that behalf, hereby order :—

1. In The Government of Alderney Law, 1987, as amended(b), in sections 49(2), 49(5), 51(3)(a), 58(1), 61(3)(a), 61(5) and 62(1) (in the definition of the expression "Finance Committee"), for the references (howsoever expressed) to the Finance Committee there shall be substituted references to the Policy and Finance Committee.

Variation of references to Finance Committee.

2. In The Government of Alderney Law, 1987, as amended, in sections 47(4)(a)(i) and (ii), 47(4)(b) and 47(4)(c) for the words "Committee for Agriculture and Fisheries" there shall be substituted "General Services Committee".

Transfer of functions to General Services Committee.

Transfer of functions to States Engineer.

3. In The Government of Alderney Law, 1987, as amended, in sections 55(1), 55(2) and 62(1) (in the definitions of the expressions "the Clerk of Works" and "the Surveyor") for the references (howsoever expressed) to the Surveyor and Clerk of Works there shall be substituted references to the States Engineer.

Savings and transitional provisions.

4. Anything done before the date of the commencement of this Ordinance or in the process of being done on that date by or in relation to:-

(a) the Finance Committee; or

(b) the Surveyor or Clerk of Works (within the meaning of The Government of Alderney Law, 1987, as amended);

shall have effect as if done or (as the case may be) may be continued by or in relation to, respectively, the Policy and Finance Committee or States Engineer.

Interpretation.

5. The provisions of The Interpretation (Guernsey) Law, 1948(c) shall apply to the interpretation of this Ordinance.

Citation.

6. This Ordinance may be cited as The States Committees and States Engineer (Transfer of Functions) (Alderney) Ordinance, 1999.
