Ordinance of the States **XXIII**

1987

Made 30th September, 1987.

Coming into Operation ... 9th November, 1987.

The Attendance and Invalid Care Allowances (Guernsey) Ordinance, 1987

THE STATES, in pursuance of their Resolution of the 24th day of June, 1987, and in exercise of the powers conferred upon them by sections 1(4)(b), 2(3)(b) and 3 of the Attendance and Invalid Care Allowances (Guernsey) Law, 1984, as amended(a), hereby order:—

1. The amount determined for the purposes of section 1(4)(b) of the Law (which provides that an attendance allowance shall not be payable in respect of any person whose current annual income exceeds that amount) shall be fifteen thousand pounds. Entitlement to attendance allowance.

2. The amount determined for the purposes of section 2(3)(b) of the Law (which provides that a person shall not be entitled to an invalid care allowance if his current annual income exceeds that amount) shall be fifteen thousand pounds. Entitlement to invalid care allowance.

Rates of allowances.

3. (1) The weekly rate of an attendance allowance determined for the purposes of section 3 of the Law shall be thirty-two pounds.

(2) The weekly rate of an invalid care allowance determined for the purposes of section 3 of the Law shall be twenty-six pounds.

Interpretation.

4. (1) In this Ordinance the expression "the Law" means the Attendance and Invalid Care Allowances (Guernsey) Law, 1984, and any other expressions have the same meanings as in the Law.

(2) Except where the context otherwise requires, any reference in this Ordinance to any enactment shall be construed as including a reference to that enactment as amended, repealed, replaced, extended or applied by or under any other enactment including this Ordinance.

(3) The Interpretation (Guernsey) Law, 1948(b), shall apply to the interpretation of this Ordinance throughout the Islands of Guernsey, Alderney, Herm and Jethou.

Extent.

5. This Ordinance shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Repeal.

6. Section 1, section 2 and section 3 of the Attendance and Invalid Care Allowances (Guernsey) Ordinance, 1986(c), are hereby repealed.

Citation.

7. This Ordinance may be cited as the Attendance and Invalid Care Allowances (Guernsey) Ordinance, 1987.

8. This Ordinance and the Attendance and Invalid Care Allowances (Guernsey) Ordinance, 1986, may be cited together as the Attendance and Invalid Care Allowances (Guernsey) Ordinances, 1986 and 1987. Collective title.

9. This Ordinance shall come into force on the 9th day of November, 1987. Commencement.
