1991

Made 27th November, 1991.
Coming into operation 28th November, 1991.

**The Central Outdoor Assistance Board
(Amendment) Ordinance, 1991**

THE STATES, in pursuance of their Resolution of 25th September, 1991(a) and in exercise of the powers conferred upon them by Article XXII of the Public Assistance Law, 1937, as amended(b) and by section 2 of the Public Assistance (Amendment) (Guernsey) Law, 1990, hereby order:-

Amendment.

1. In the Central Outdoor Assistance Board Regulations, 1963, as amended(c) -

(a) Article XXXIV of Billet d'Etat No. XXIII of 1991.

(c) G.S.I. No.4 of 1963 (set out in Tome XIII, p.274); No. 1 of 1982 (set out in Tome XXII, p.163); and No. 15 of 1990 (set out in Ordinance No. XXVI of 1990).

(a) in Regulation 1(1) for the definition of "requirements" substitute -

"requirements" means the ordinary maximum rate of outdoor assistance excluding any medical, surgical, optical, aural or dental requirements.";

(b) in paragraph 2(2) of the Schedule for "one hundred pounds until midnight on 30th November, 1990, and one hundred and ten pounds thereafter" substitute "£125";

(c) after paragraph 9 of the Schedule insert -

"Ordinary maximum rates of outdoor assistance:-

10. The ordinary maximum rates of outdoor assistance shall be:-

(a) for a husband
and wife £60.00

(b) for a person
living alone
or a house-
holder not
falling within
sub-paragraph

(a) who is
responsible

	necessities	
	and rent	£37.50
(c)	for any	
	other person	
	who is -	
	aged 18	
	and over	£27.50

Repeal.

2. The Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1990(d) and the Regulations set out in the Schedule thereto are repealed.

Citation.

3. This Ordinance may be cited as the Central Outdoor Assistance Board (Amendment) Ordinance, 1991.

Commencement.

4. This Ordinance shall come into force on 28th November, 1991.
