The Central Outdoor Assistance Board Regulations (Amendment) (No. 2) Ordinance, 1983

WHEREAS the Central Outdoor Assistance Board on the twenty-first day of September, nineteen hundred and eighty-three, in exercise of the powers conferred upon it by Article VI of the Public Assistance Law, 1937(a), made the Regulations set out in the Schedule to this Ordinance:

NOW THEREFORE the States, in pursuance of their Resolution of the thirtieth day of November, nineteen hundred and eighty-three, and in exercise of the powers now vested in them by the said Article VI and of all other powers enabling them in that behalf, hereby order:—

1. The Regulations made by the Central Outdoor Assistance Board on the twenty-first day of September, nineteen hundred and eighty-three, and set out in the Schedule to this Ordinance are hereby approved.

Citation. 2. This Ordinance may be cited as the Central Outdoor Assistance Board Regulations (Amendment) (No. 2) Ordinance, 1983.

Commencement. 3. This Ordinance shall come into force on the thirtieth day of November, nineteen hundred and eighty-three.

The Central Outdoor Assistance Board (Amendment) (No. 2) Regulations, 1983

THE CENTRAL OUTDOOR ASSISTANCE BOARD, in exercise of the powers conferred upon it by Article VI of the Public Assistance Law, 1937, hereby makes the following Regulations:—

1. In sub-paragraph (2) of paragraph two of the Schedule to the Central Outdoor Assistance Board Regulations, 1963, as amended, the words “sixty-three pounds” are hereby deleted and the words “sixty-six pounds” are hereby substituted therefor. Amendment to Regulations of 1963.

2. Regulation four of the Central Outdoor Assistance Board (Amendment) Regulations, 1983, is hereby repealed. Repeal.

3. These Regulations may be cited as the Central Outdoor Assistance Board (Amendment) (No. 2) Regulations, 1983. Citation.

4. These Regulations, the Central Outdoor Assistance Board (Amendment) Regulations, 1983, and the Central Outdoor Assistance Board Regulations, 1939 to 1981, may be cited together as the Central Outdoor Assistance Board Regulations, 1939 to 1983. Collective title.

5. These Regulations shall come into operation on the day next following their approval by the States.
