**The Central Outdoor Assistance Board  
Regulations (Amendment) Ordinance, 1983**

WHEREAS the Central Outdoor Assistance Board on the thirty-first day of January, nineteen hundred and eighty-three, in exercise of the powers conferred upon it by Article VI of the Public Assistance Law, 1937(a), made the Regulations set out in the Schedule to this Ordinance:

NOW THEREFORE the States, in pursuance of their Resolution of the thirtieth day of March, nineteen hundred and eighty-three, and in exercise of the powers now vested in them by the said Article VI and of all other powers enabling them in that behalf, hereby order:—

1. The Regulations made by the Central Outdoor Assistance Board on the thirty-first day of January, nineteen hundred and eighty-three, and set out in the Schedule to this Ordinance are hereby approved. Regulations of 1983 approved.

**Citation.** 2. This Ordinance may be cited as the Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1983.

**Commencement.** 3. This Ordinance shall come into force on the thirty-first day of March, nineteen hundred and eighty-three.

## **The Central Outdoor Assistance Board (Amendment) Regulations, 1983**

THE CENTRAL OUTDOOR ASSISTANCE BOARD, in exercise of the powers conferred upon it by Article VI of the Public Assistance Law, 1937, hereby makes the following Regulations:—

1. The Central Outdoor Assistance Board Regulations, 1963, as amended, are hereby further amended as follows:—

- (a) in sub-paragraph (b) of paragraph (1) of Regulation four thereof the words “one pound and fifty new pence” are repealed and the words “two pounds and fifty new pence” are substituted therefor;
- (b) in the Schedule thereto—
  - (i) in sub-paragraph (2) of paragraph two thereof the words “sixty pounds” are deleted and the words “sixty-three pounds” are substituted therefor;
  - (ii) in paragraph seven thereof the words “five pounds” are deleted and the words “ten pounds” are substituted therefor;
  - (iii) in paragraph eight thereof the words “two pounds” are deleted and the words “three pounds” are substituted therefor.

2. These Regulations, the Central Outdoor Assistance Board Regulations, 1939, the Central Outdoor Assistance Board Regulations, 1963, the Central

Outdoor Assistance Board (Amendment) Regulations, 1967, and the Central Outdoor Assistance Board (Amendment) Regulations, 1981, shall be construed as one.

**Citation.** 3. These Regulations may be cited as the Central Outdoor Assistance Board (Amendment) Regulations, 1983.

**Collective title.** 4. These Regulations and the Central Outdoor Assistance Board Regulations, 1939 to 1981, may be cited together as the Central Outdoor Assistance Board Regulations, 1939 to 1983.

**Commencement.** 5. These Regulations shall come into operation on the day next following their approval by the States.
