**The Central Outdoor Assistance Board
Regulations (Amendment) Ordinance, 1987**

WHEREAS the Central Outdoor Assistance Board on the 9th day of September, 1987, in exercise of the powers conferred upon it by Article VI of the Public Assistance Law, 1937(a), made the Regulations set out in the Schedule to this Ordinance:

NOW THEREFORE the States, in pursuance of their Resolution of the 25th day of November, 1987, and in exercise of the powers now vested in them by the said Article VI and of all other powers enabling them in that behalf, hereby order:—

1. The Regulations made by the Central Outdoor Assistance Board on the 9th day of September, 1987, and set out in the Schedule to this Ordinance are hereby approved. Regulations

Repeal. 2. The Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1986(b), is hereby repealed.

Citation. 3. This Ordinance may be cited as the Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1987.

Commencement. 4. This Ordinance shall come into force on the 27th day of November, 1987.

**The Central Outdoor Assistance Board
(Amendment) Regulations, 1987**

THE CENTRAL OUTDOOR ASSISTANCE BOARD, in exercise of the powers conferred upon it by Article VI of the Public Assistance Law, 1937, hereby makes the following Regulations:—

1. In sub-paragraph (2) of paragraph 2 of the Schedule to the Central Outdoor Assistance Board Regulations, 1963, as amended, the words “seventy-five pounds” are hereby repealed and the words “eighty-three pounds” are hereby substituted therefor. Amendment to Regulations of 1963.

2. The Central Outdoor Assistance Board (Amendment) Regulations, 1986, are hereby repealed. Repeal.

3. These Regulations may be cited as the Central Outdoor Assistance Board (Amendment) Regulations, 1987. Citation.

4. These Regulations, the Central Outdoor Assistance Board (Amendment) Regulations, 1983, and the Central Outdoor Assistance Board Regulations, 1939 to 1981, may be cited together as the Central Outdoor Assistance Board Regulations, 1939 to 1987. Collective title.

5. These Regulations shall come into operation on the day next following their approval by the States. Commencement.
