**The Central Outdoor Assistance  
Board Regulations (Amendment)  
Ordinance, 1990**

THE STATES, in pursuance of their Resolution of the 27th day of September, 1990, and in exercise of the powers now vested in them by Article VI of the Public Assistance Law, 1937(*a*) and of all other powers enabling them in that behalf, hereby order:—

1. The Regulations made by the Central Outdoor Assistance Board on the 6th day of August, 1990 and set out in the schedule to this Ordinance are hereby approved. Regulations of 1990 approved.

2. The Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1989(*b*) is hereby repealed. Repeal.

Citation. 3. This Ordinance may be cited as the Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1990.

4. This Ordinance shall come into force on the 28th day of September, 1990.

## SCHEDULE

## Section 1

### The Central Outdoor Assistance Board (Amendment) Regulations, 1990

THE CENTRAL OUTDOOR ASSISTANCE BOARD, in exercise of the powers conferred upon it by Article VI of the Public Assistance Law, 1937, hereby makes the following Regulations:—

Amendment to Regulations of 1963. 1. In sub-paragraph (2) of paragraph 2 of the Schedule to the Central Outdoor Assistance Board Regulations, 1963, as amended, the words “one hundred pounds” are hereby repealed and the words “one hundred pounds until midnight on 30th November, 1990, and one hundred and ten pounds thereafter” are hereby substituted therefore.

Repeal. 2. The Central Outdoor Assistance Board (Amendment) Regulations, 1989, are hereby repealed.

Citation. 3. These Regulations may be cited as the Central Outdoor Assistance Board (Amendment) Regulations, 1990.

Collective Title. 4. These Regulations and the Central Outdoor Assistance Board Regulations, 1939 to 1989, may be cited together as the Central Outdoor Assistance Board Regulations, 1939 to 1990.

5. These Regulations shall come into operation on the day next following their approval by the States. Commence-  
ment.
