**The Central Outdoor Assistance Board Regulations
(Amendment) Ordinance, 1993**

THE STATES, in pursuance of their Resolution of the 8th day of December, 1993, (a) and in exercise of the powers conferred on them by Article XXII of the Public Assistance Law, 1937, as amended (b), hereby order:-

Amendment to the Regulations of 1963

1. The Central Outdoor Assistance Board Regulations, 1963, as amended, set out in the Schedule to the Central Outdoor Assistance Board Regulations Ordinance, 1963 (c), are further amended as follows:-

- (a) in Regulation 4 (1)(b), for the words "two pounds and fifty new pence" substitute "£5";
- (b) in paragraph 2(2) of the Schedule to the Regulations, for "£130" substitute "£140";
- (c) in paragraph 4 of the Schedule to the Regulations, sub-paragraphs (a) and (b) are repealed;

"(e) any allowance payable under the Family Allowances (Guernsey) Law, 1959";

(e) for paragraph 10 of the Schedule to the Regulations, substitute the following:-

"Ordinary maximum rates of outdoor assistance

10. The ordinary maximum rates of outdoor assistance shall be:-

4. This Ordinance shall come into force on 9 December 1993.
