**The Central Outdoor Assistance Board Regulations  
(Amendment) Ordinance, 1995.**

**THE STATES**, in pursuance of their Resolution of the 26th day of July, 1995(a), and in exercise of the powers conferred upon them by Article XXII of the Public Assistance Law, 1937, as amended(b), hereby order:-

**Amendment to the Regulations of 1963.**

1. The Central Outdoor Assistance Board Regulations, 1963, as amended, set out in the Schedule to the Central Outdoor Assistance Board Regulations Ordinance, 1963(c), are further amended as follows-

- (a) in Regulation 1(1) immediately after the definition of "net weekly earnings" the following words are inserted-

- (c) Recueil d'Ordonnances, Tome XIII, p. 274; Tome XXII, p. 163; No. XXXIX of 1991; No. XXXI of 1993; No. XXXIV of 1994.

"and for the purposes of the definition of the expression "net weekly earnings" there shall be included any invalid care allowance payable in accordance with the Attendance and Invalid Care Allowances (Guernsey) Law, 1984;"

- (b) in paragraph 2(2) of the Schedule to the Regulations, for "£150" substitute "£162";
- (c) for paragraph 6(1) of the Schedule to the Regulations substitute the following paragraph-

"(1) There shall be wholly disregarded-

- (a) any payment or payments of a temporary nature from any charitable source;
  - (b) any attendance allowance granted under the Attendance and Invalid Care Allowances (Guernsey) Law, 1984.";
- (d) for paragraph 10 of the Schedule to the Regulations, substitute the following paragraph-

**"Ordinary maximum rates of outdoor assistance.**

10. The ordinary maximum rates of outdoor assistance shall be-

- (a) for two persons living together as husband and wife, £80.00;
- (b) for a person living alone or a householder not falling within subparagraph (a) who is responsible for household necessities and rent, £48.00;

- (c) for any other person who is-
- (i) aged 18 or over, £37.00;
  - (ii) aged 16 or over but under 18, £29.00;
  - (iii) aged 13 or over but under 16, £26.50;
  - (iv) aged 11 or over but under 13, £24.00;
  - (v) aged 5 or over but under 11, £22.00;
  - (vi) aged under 5, £21.00."

**Repeal.**

2. The Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1994(d) is hereby repealed.

**Citation.**

3. This Ordinance may be cited as the Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1995.

**Commencement.**

4. This Ordinance shall come into force on 10th day of November 1995.
