The Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1996.

THE STATES, in pursuance of their Resolution of the 27th day of June 1996(a), and in exercise of the powers conferred upon them by Article XXII of the Public Assistance Law, 1937, as amended(b), hereby order:-

Amendment to the Regulations of 1963.

1. The Central Outdoor Assistance Board Regulations, 1963, as amended, set out in the Schedule to the Central Outdoor Assistance Board Regulations Ordinance, 1963(c), are further amended as follows-

- (a) the text of regulation 3 is renumbered as paragraph (1) and the following paragraphs are inserted thereafter-

- (c) Recueil d'Ordonnances, Tome XIII, p. 274; Tome XXII, p. 163; No. XXXIX of 1991; No. XXXI of 1993; No. XXXIV of 1994; and No. XXIV of 1995.

"(2) Where the weekly amount of assistance determined in accordance with the provisions of these regulations would be less than £1, no assistance shall be payable.

(3) Where the weekly amount of assistance determined in accordance with these regulations exceeds £1, but is not a multiple of 25p, the amount by which it exceeds such a multiple shall, if it is 13p or more, be treated as 25p and, if it is 12p or less, be disregarded.;

(b) in paragraph 2(2) of the Schedule to the Regulations, for "£162.00" substitute "£168.50";

(c) in paragraph 6 of the Schedule to the Regulations-

(i) for the words "four pounds" in subparagraph (2) substitute "£10";

(ii) for the words "two pounds" in subparagraph (3)(i) substitute "£5";

(iii) for each occurrence of the words "four pounds" in subparagraph (3)(ii) substitute "£10";

(d) in paragraph 7 of the Schedule to the Regulations for the words "ten pounds" substitute "£15";

(e) for paragraph 10 of the Schedule to the Regulations, substitute the following-

"Ordinary maximum rates of outdoor assistance.

10. The ordinary maximum rates of outdoor assistance shall be-

(a) for two persons living together as husband and wife, £90.00;

- (b) for a person living alone or a householder not falling within (a) of this paragraph who is responsible for household necessities and rent, £55.00;
- (c) for any other person who is-
 - (i) aged 18 and over, £44.00;
 - (ii) aged 16 or over but under 18, £33.00;
 - (iii) aged 13 or over but under 16, £28.00;
 - (iv) aged 11 or over but under 13, £24.00;
 - (v) aged 5 or over but under 11, £22.00;
 - (vi) aged under 5, £20.00"

Repeals.

2. The Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1995(d) is hereby repealed.

Citation.

3. This Ordinance may be cited as the Central Outdoor Assistance Board Regulations (Amendment) Ordinance, 1996.

Commencement.

4. This Ordinance shall come into force on 10th day of January 1997.
