## **The Central Outdoor Assistance Board Regulations (Repeal) Ordinance, 2005**

**THE STATES**, in pursuance of their Resolution of the 27<sup>th</sup> April 2005<sup>a</sup> and in exercise of the powers conferred upon them by Article XXII of the Public Assistance Law, 1937, as amended<sup>b</sup> and all other powers enabling them in that behalf, hereby order:-

### **Repeal of Central Outdoor Assistance Board Regulations Ordinances.**
