

**The Driving Licences (Amendment) (No. 3) (Guernsey) Ordinance, 1996**

**THE STATES LEGISLATION COMMITTEE**, in exercise of the powers conferred upon the States by section 2 of the Motor Taxation and Licensing (Guernsey) Law, 1987, as amended<sup>1</sup>, and on the Committee by Article 66(3) of the Reform (Guernsey) Law, 1948, as amended<sup>2</sup>, hereby orders:-

**Amendments to 1995 Ordinance.**

1. In the Table contained in Schedule 6 to the Driving Licences (Guernsey) Ordinance, 1995, as amended<sup>3</sup> -

(a) the entries opposite the letter "A" in the first column are amended as follows-

(i) in the second column, immediately after the figures "17" insert-

"or, in the case of a person who has at any time held a licence issued pursuant to Article 10(a)(2) of the Law entitled "Loi relative aux Automobiles" registered on the 11th December, 1926<sup>4</sup> ("the 1926 Law") or a provisional licence for that category issued pursuant to Articles 2(1) and 4 of the Law entitled "Loi Supplémentaire relative aux Automobiles (Autorisations à Conduire)" registered on the 17th June, 1939<sup>5</sup> ("the 1939 Law"), 16";

(ii) in the fourth column, immediately after the words "18 years of age" insert-

", other than a person who has at any time held a licence issued pursuant to Article 10(a)(2) of the 1926 Law or a provisional licence for that category issued pursuant to Articles 2(1) and 4 of the 1939 Law,";

(b) the entries opposite the letter and figure "A1" in the first column are amended as follows-

(i) in the second column, immediately after the figures "16" insert-

"or, in the case of a person who has at any time held a licence issued pursuant to Article 10(a)(1) of the 1926 Law or a provisional licence for that category issued pursuant to Articles 2(1) and 4 of the 1939 Law, 14";

(ii) in the fourth column, immediately after the words "17 years of age" insert-

", other than a person who has at any time held a licence issued pursuant to Article 10(a)(1) of the 1926 Law or a provisional licence for that category issued pursuant to Articles 2(1) and 4 of the 1939 Law,".

### **Citation**

2. This Ordinance may be cited as the Driving Licences (Amendment) (No. 3) (Guernsey) Ordinance, 1996.

### **Commencement**

3. This Ordinance shall be deemed to have come into force on 1st September, 1995.
