Made 30th September, 1992.
Coming into operation 5th October, 1992.

The Driving Tests (Increase of Fees) Ordinance, 1992

THE STATES, in pursuance of their Resolution of the 24th day of June, 1992(a) and in exercise of the powers conferred upon them by section 18 of the "Loi relative aux Automobiles" of the 11th December, 1926(b), section 8 of the "Loi Supplémentaire relative aux Automobiles (Autorisations à Conduire), 1939(c), section 3 of the Public Transport (Guernsey) Law, 1984(d) and of all other powers enabling them in that behalf, hereby order:-

Amendment to Ordinance of 1929

1. (1) In Article VIII(4) of the Ordinance entitled "Ordonnance relative au Trafic Véhiculaire en cette Ile" of the 2nd March, 1929, as amended(e), for the words "a fee of £12" substitute "a fee in the sum prescribed by Schedule 1 to this Ordinance".

(2) After Article XIV of the said Ordinance, insert the Schedule set out in the Schedule to this Ordinance.

The fee payable prior to taking a test for a permit to drive a vehicle to which the provision of the "Loi relative aux Automobiles" of the 20th November, 1926 set out in column (1) of the Table below applies shall be the corresponding sum set out in column (2) thereof.
