

The Drug Trafficking Offences (Bailiwick of Guernsey) Law, 1988
(Specified Countries and Territories)
(Amendment) Ordinance, 1998

THE STATES, in exercise of the powers conferred upon them by section 20 of the Drug Trafficking Offences (Bailiwick of Guernsey) Law, 1988^a and on the representations of the States Advisory and Finance Committee, hereby order:-

Amendments to Ordinance of 1991.

1. (1) In section 7 of the Drug Trafficking Offences (Bailiwick of Guernsey) Law, 1988 (Specified Countries and Territories) Ordinance, 1991^b ("the Ordinance") after "'appropriate authority of a specified country" means an authority specified opposite that country in the First Schedule to this Ordinance" add "or, where no authority is so specified, the authority appearing to the Royal Court to be an appropriate authority for the purposes of this Ordinance".
