**The Guernsey Social Security Authority  
(Transfer of Functions) Ordinance, 1993**

**THE STATES**, in pursuance of their Resolution of the 30th day of June, 1993(a), and in exercise of the powers conferred upon them by section 1 of the Public Functions (Transfer and Performance) (Bailiwick of Guernsey) Law, 1991(b), hereby order:-

**Transfer of functions to Social Security Authority.**

1. The functions of the States Insurance Authority under the enactments set out in Schedule 1 are hereby transferred to the Guernsey Social Security Authority.

**Savings.**

2. (1) Anything done by or in relation to the States Insurance Authority under any enactment set out in Schedule 1 before the commencement of this Ordinance shall have effect as if done by or in relation to the Guernsey Social Security Authority.

(2) Anything in the process of being done by or in relation to the States Insurance Authority under any enactment set out in Schedule 1 at the date of the

commencement of this Ordinance may be continued by or in relation to the Guernsey Social Security Authority.

**Amendments.**

3. The enactments set out in Schedule 2 are amended as therein mentioned.

4. Any reference in this Ordinance to an enactment is a reference thereto as amended, extended or applied.

**Citation.**

5. This Ordinance may be cited as the Guernsey Social Security Authority (Transfer of Functions) Ordinance, 1993.
