The Health Service (Benefit) (Amendment) (No. 2) Ordinance, 2003

THE STATES, in pursuance of their Resolution of the 24th day of September 2003^a, and in exercise of the powers conferred upon them by sections 6, 13, 35 and 39 of the Health Service (Benefit) (Guernsey) Law, 1990^b, as amended and all other powers enabling them, hereby order:-
