### **The Health Service (Benefit) (Amendment) Ordinance, 1991**

THE STATES, in pursuance of their Resolution of the 25th April, 1991, and in exercise of the powers conferred upon them by section 35 of the Health Service (Benefit) (Guernsey) Law, 1990(a) and all other powers enabling them in that behalf, hereby order:-

#### Amendment.

1. For section 3(2)(a) of the Health Service (Benefit) Ordinance, 1990(b) substitute -

"(a) to a person who has attained the age of 65 years;".

#### Repeals.

2. The Ordinances set out in the Schedule are repealed.

3. This Ordinance may be cited as the Health Service (Benefit) (Amendment) Ordinance, 1991.

4. This Ordinance shall come into force on 1st June, 1991.
