The Health Service (Benefit) (Amendment) Ordinance, 1997

THE STATES, in pursuance of their Resolution of the 1st day of August, 1997^a, and in exercise of the powers conferred upon them by sections 13 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990^b, as amended, hereby order:-

Amendment of 1990 Ordinance.

1. (1) ...

(2) Section 7 of the Health Service (Benefit) Ordinance, 1990 is repealed.
