## **The Health Service (Benefit) (Amendment) Ordinance, 2001**

**THE STATES LEGISLATION COMMITTEE**, in pursuance of the Resolution of the States of the 27<sup>th</sup> September, 2001<sup>a</sup>, and in exercise of the powers conferred on the States by sections 6, 13 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990, as amended<sup>b</sup> and on the Legislation Committee by article 66 of the Reform (Guernsey) Law, 1948, as amended<sup>c</sup>, hereby orders:-

### **Amendment of 1990 Ordinance.**

1. For Schedule 1 to the Health Service (Benefit) Ordinance, 1990, as amended<sup>d</sup>, substitute the schedule set out in the Schedule to this Ordinance.

### **Repeal.**

2. The Health Service (Benefit) (Amendment) Ordinance, 2000<sup>e</sup> is repealed.

### **Extent.**

3. This Ordinance shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

**Citation.**

4. This Ordinance may be cited as the Health Service (Benefit) (Amendment) Ordinance, 2001.

**Commencement.**

5. This Ordinance shall come into force on the 1<sup>st</sup> January, 2002.
