## **The Health Service (Benefit) (Amendment) Ordinance, 2010**

**THE STATES**, in pursuance of their Resolution of the 30<sup>th</sup> September, 2010<sup>a</sup>, and in exercise of the powers conferred upon them by sections 2, 6, 13, 35 and 39 of the Health Service (Benefit) (Guernsey) Law, 1990<sup>b</sup>, as amended and all other powers enabling them, hereby order:-

### **Amendment of 1990 Ordinance.**

1. For Schedule 1 to the Health Service (Benefit) Ordinance, 1990<sup>c</sup>, substitute the schedule set out in the Schedule to this Ordinance.

### **Interpretation.**

2. (1) Unless the context otherwise requires, references in this Ordinance to an enactment are references thereto as amended, re-enacted (with or without modification), extended or applied.

(2) The Interpretation (Guernsey) Law, 1948<sup>d</sup> shall apply to the interpretation of this Ordinance throughout the Islands of Guernsey, Alderney,

3. The Health Service (Benefit) (Amendment) Ordinance, 2009<sup>e</sup> is repealed.

**Citation.**

4. This Ordinance may be cited as the Health Service (Benefit) (Amendment) Ordinance, 2010.

**Extent.**

5. This Ordinance shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

**Commencement.**

6. This Ordinance shall come into force on the 1<sup>st</sup> January, 2011.
