## **The Income Tax (Guernsey) (Approval of Agreements) Ordinance, 2009**

**THE STATES**, in exercise of the powers conferred on them by section 75C of the Income Tax (Guernsey) Law, 1975, as amended<sup>a</sup>, and all other powers enabling them in that behalf, hereby order:-

### **Approval of Agreements.**

1. The agreements providing for the obtaining and exchanging of information in relation to tax made between the States of Guernsey and the governments of -

- (a) the Kingdom of the Netherlands, signed at St Peter Port, Guernsey on the 25<sup>th</sup> April, 2008,
- (b) the Kingdom of Denmark, signed at Helsinki on the 28<sup>th</sup> October, 2008,
- (c) the Faroe Islands, signed at Helsinki on the 28<sup>th</sup> October, 2008,
- (d) the Republic of Finland, signed at Helsinki on the 28<sup>th</sup> October, 2008,
- (e) Greenland, signed at Helsinki on the 28<sup>th</sup> October, 2008,
- (f) the Republic of Iceland, signed at Helsinki on the 28<sup>th</sup> October, 2008,

- (g) the Kingdom of Norway, signed at Helsinki on the 28<sup>th</sup> October, 2008, and
- (h) the Kingdom of Sweden, signed at Helsinki on the 28<sup>th</sup> October, 2008,

and which were registered by the Royal Court on the 5<sup>th</sup> January, 2009 are, pursuant to section 75C of the Income Tax (Guernsey) Law, 1975, as amended, hereby specified for the purposes of that Law.

**Citation.**

2. This Ordinance may be cited as the Income Tax (Guernsey) (Approval of Agreements) Ordinance, 2009.

**Commencement.**

3. This Ordinance shall come into force on the 28<sup>th</sup> January, 2009.
