## **The Long-term Care Insurance (Guernsey) (Annual Grant and Rates) Ordinance, 2007**

**THE STATES**, in pursuance of their Resolutions of the 28<sup>th</sup> September 2006<sup>a</sup> and the 28<sup>th</sup> September, 2007<sup>b</sup> and in exercise of the powers conferred on them by sections 2 and 5 of the Long-term Care Insurance (Guernsey) Law, 2002<sup>c</sup> and all other powers enabling them, hereby order: –

### **Amount of States Long-term Care Insurance Annual Grant.**

1. The percentage specified for the purposes of section 2 of the Long-term Care Insurance (Guernsey) Law, [2002] is 0 per centum.

**Interpretation.**

4. (1) In this Ordinance unless the context otherwise requires "**nursing home**" and "**residential home**" have the meanings given by section 18(1) of the Nursing Homes and Residential Homes (Guernsey) Law, 1976<sup>d</sup>.

(2) Unless the context otherwise requires, references in this Ordinance to an enactment are references thereto as amended, re-enacted (with or without modification), extended or applied.

(3) The Interpretation (Guernsey) Law, 1948<sup>e</sup> shall apply to the interpretation of this Ordinance throughout the Islands of Guernsey, Alderney, Herm and Jethou.

**Repeals.**

5. The Long-term Care Insurance (Guernsey) (Annual Grant and Rates) Ordinance, 2006<sup>f</sup> is repealed.
