**The Misuse of Drugs (Bailiwick of
Guernsey) Law, 1974 (Modification)
Ordinance, 1988**

THE STATES LEGISLATION COMMITTEE,
in exercise of the powers conferred upon it by
Article 66(3) of the Reform (Guernsey) Law, 1948(a)
and sections 1(2), 9, 21(a) and 30 of the Misuse of
Drugs (Bailiwick of Guernsey) Law, 1974(b), as
amended(c), hereby orders:—

1. In paragraph 1(c) of Part I of the First Schedule
to the Misuse of Drugs (Bailiwick of Guernsey) Law,
1974, as amended, for the references to “*N*-alkyl-
phenethy-lamine” and “*N*-alkyl-*a*-methylphenethy-
a-ethylphenethylamine” substitute “*N*-alkylphene-
thylamine” and “*N*-alkyl- α methylphenethylamine,
 α -ethylphenethylamine” respectively.

Ordinance. 2. (1) In paragraph 6 of the First Schedule to the Misuse of Drugs (Bailiwick of Guernsey) Ordinance, 1976^(d), as amended^(e), delete the number "180" and substitute "100".

(2) In paragraph 1 of the Second Schedule to the said Ordinance, for the reference to "Acctorphine" substitute "Acetorphine".

(3) In paragraph 1(c) of the Fourth Schedule to the said Ordinance, for the reference to "*N*-alkyl phenethylamine" substitute "an *N*-alkylphenathylamine".

Citation. 3. This Ordinance may be cited as the Misuse of Drugs (Bailiwick of Guernsey) Law, 1974 (Modification) Ordinance, 1988.

Collective
title. 4. This Ordinance and the Misuse of Drugs (Bailiwick of Guernsey) Law, 1974 (Modification) Ordinances, 1976 and 1983 may be cited together as the Misuse of Drugs (Bailiwick of Guernsey) Law, 1974 (Modification) Ordinances, 1976 to 1988.
