**The Motor Vehicles (Provisional Driving Licences) (Amendment) Ordinance, 1970**

THE STATES, in pursuance of their Resolution of the twenty-ninth day of July, nineteen hundred and seventy, and in exercise of the powers now vested in them by Article 8 of the Law entitled "Loi Supplémentaire relative aux Automobiles (Autorisations à Conduire), 1939"(a), as amended, the powers conferred upon them by the Indirect Taxes, Duties and Impôts (Increase of Rates) (Guernsey) Law, 1970(b), and of all other powers enabling them in that behalf, hereby order:—

1. The first column of the Schedule to the Motor Vehicles (Provisional Driving Licences) Ordinance, 1958(c), is hereby repealed and the following words and figures are substituted therefor:—

2. Section four of the Motor Vehicles (Miscellaneous Provisions) Ordinance, 1962(*d*), as amended(*e*), is hereby repealed and the following section is substituted therefor:—

“Restriction on the grant of provisional driving licences.

4. Except where the States Board of Administration in its discretion otherwise determines, a provisional driving licence of any category shall not be granted to a person who has previously held a provisional driving licence of that category unless there shall have elapsed a period of not less than three months since the expiration of the last previous provisional driving licence held by him.”.

3. (1) The Motor Vehicles (Miscellaneous Provisions) (Amendment) Ordinance, 1967(*e*), is hereby repealed. Repeals.

(2) Section five of the Indirect Taxes, Duties and Impôts (Increase of Rates) Ordinance, 1969(*f*) is hereby repealed.

4. This Ordinance may be cited as the Motor Vehicles (Provisional Driving Licences) (Amendment) Ordinance, 1970, and shall come into force on the first day of December, nineteen hundred and seventy. Citation and commencement.
