**The Prohibited and One-Way Streets  
(Amendment) (No. 5) Ordinance, 1968**

THE STATES, in pursuance of their Resolution of the thirtieth day of October, nineteen hundred and sixty-eight, hereby order:—

1. The Prohibited and One-Way Streets Ordinance, 1956, as amended(a), is hereby further amended as follows:—

(a) paragraph 25 of the Second Schedule thereto is hereby repealed and the following paragraph is hereby substituted therefor:—

“ 25. Rue Maurepas, Saint Peter Port, from South to East.”;

(b) in the Second Schedule thereto immediately after paragraph 56 thereof, there are hereby inserted the following additional paragraphs numbered “ 57 ” and “ 58 ”:—

(a) Recueil d'Ordonnances Tome XI, pp. 183, 243 and 294; Tome XII, p. 312; Tome XIII, pp. 43, 214 and 228; Tome XIV, pp. 8, 52, 247 and 329; Nos. XXXIV and L of 1967; Nos. XV, XVIII, XXVI and XLI of 1968.

“ 57. The road to the West of the South Plantation, South Esplanade, Saint Peter Port, from North to South.

58. Pointes Lane, Saint Andrew's, from North to South.”.

**Repeal.**

2. Subsection (2) of section three of the Prohibited and One-Way Streets (Amendment) (No. 3) Ordinance, 1968, is hereby repealed.

**Citation and collective title.**

3. (1) This Ordinance may be cited as the Prohibited and One-Way Streets (Amendment) (No. 5) Ordinance, 1968.

(2) This Ordinance, the Prohibited and One-Way Streets (Amendment) (No. 4) Ordinance, 1968, the Prohibited and One-Way Streets (Amendment) (No. 3) Ordinance, 1968, the Prohibited and One-Way Streets (Amendment) (No. 2) Ordinance, 1968, the Prohibited and One-Way Streets (Amendment) Ordinance, 1968, and the Prohibited and One-Way Streets Ordinances, 1956 to 1967, may be cited together as the Prohibited and One-Way Streets Ordinances, 1956 to 1968.

**Commencement.**

4. This Ordinance shall come into force on the first day of January, nineteen hundred and sixty-nine.
