## **The Road Traffic Temporary Regulations and Clearways (Amendment) Ordinance, 1990**

**THE STATES**, in pursuance of their Resolution of the 29<sup>th</sup> March 1990<sup>a</sup>, hereby order: –

### **Temporary Regulations.**

**1.** (1) In sections (1) and (2) of Article X of the Ordinance entitled "Ordonnance relative au Trafic Véhiculaire en cette Île" of 2<sup>nd</sup> March, 1929<sup>b</sup> for "The Committee" there is substituted "The Island Traffic Committee".<sup>1</sup>

(2) In the Traffic Temporary Regulations Ordinance, 1950<sup>c</sup> –

(a) in section 1, for "The Island Police Committee" there is substituted "The Island Traffic Committee",<sup>2</sup>

(b) in section 2, for "six months" there is substituted "twelve months".

(3) Any regulations made by the Island Police Committee before the commencement of this Ordinance and in force on 29<sup>th</sup> April 1989 are deemed to have been made by the Island Traffic Committee as if this Ordinance (including paragraph 2(b) of this section) had been in force when the regulations were made.

(4) So much of the Road Traffic (Parking and Temporary Regulations) Ordinance, 1962<sup>d</sup> as has not already been repealed is hereby repealed.
