# ORDER IN COUNCIL



IN THE ROYAL COURT OF THE ISLAND OF GUERNSEY

*The 15th day of November, 1973, before Ernest Pattison Shanks, Esquire, Deputy Bailiff; present:—Bertram Guy Blampied, Esquire, O.B.E., Claude Fortescue Nason, Stanley Walter Gavey, Esquires, Gilbert Carey de Jersey, Esquire, C.B., D'Arcy George Le Tissier, Esquire, Edward James Lainé, Esquire, C.B.E., D.F.C., Walter Francis Robin and Richard Alan Kinnersly, Esquires, Jurats.*

The Deputy Bailiff having this day placed before the Court an Order of Her Majesty in Council dated the 24th day of October, 1973, ratifying a *Projet de Loi* entitled "The Social Insurance (Amendment) (Guernsey) Law, 1973", the Court, after the reading of the said Order in Council and after having heard Her Majesty's Procureur thereon, ordered that the said Order in Council be registered on the records of this Island and that an extract of this present Act, together with a copy of the said Order in Council, be sent by Her Majesty's Greffier to the Clerk of the Court of Alderney for registration on the records of that Island, of which Order in Council the tenor followeth:—

### The Queen's Most Excellent Majesty in Council

WHEREAS there was this day read at the Board a Report from the Right Honourable the Lords of the Committee of Council for the Affairs of Guernsey and Jersey, dated the 26th day of September 1973, in the words following, viz.:—

“YOUR MAJESTY having been pleased, by Your General Order of Reference of the 22nd day of February 1952, to refer unto this Committee the humble Petition of the States of the Island of Guernsey, setting forth:—

‘1. That, in pursuance of their Resolution of the 30th day of May 1973, the States of Deliberation at a meeting held on the 25th day of July 1973 approved a Bill or “Projet de Loi” entitled “The Social Insurance (Amendment) (Guernsey) Law, 1973” and requested the Deputy Bailiff to present a most humble Petition to Your Majesty in Council praying for Your Royal Sanction thereto. 2. That the said Bill or “Projet de Loi” is in the words and figures set forth in the Schedule hereunto annexed. And most humbly praying that Your Majesty might be graciously pleased to grant Your Royal Sanction to the Bill or “Projet de Loi” of the States of Guernsey entitled “The Social Insurance (Amendment) (Guernsey) Law, 1973” and to order that the same shall have force of law in the Islands of Guernsey, Alderney, Herm and Jethou.’


“THE LORDS OF THE COMMITTEE, in obedience to Your Majesty’s said Order of Reference, have taken the said Petition and the said Projet de Loi into consideration, and do this day humbly agree to report, as their opinion, to Your Majesty, that it may be advisable for Your Majesty to comply with the prayer of the said Petition and to approve of and ratify the said Projet de Loi.”

HER MAJESTY having taken the said Report into consideration is pleased, by and with the advice of Her Privy Council, to approve of and ratify the said Projet de Loi, and to order, as it is hereby ordered, that the same shall have the force of Law within the Island of Guernsey, Alderney, Herm and Jethou.

AND HER MAJESTY doth hereby further direct that this Order, and the said Projet de Loi (a copy whereof is hereunto annexed), be entered upon the Register of the Island of Guernsey and observed accordingly.

AND the Lieutenant Governor and Commander-in-Chief of the Island of Guernsey, the Bailiff and Jurats, and all other Her Majesty’s Officers for the time being in the said Island, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

## PROJET DE LOI

ENTITLED

### **The Social Insurance (Amendment) (Guernsey) Law, 1973**

THE STATES, in pursuance of their Resolution of the thirtieth day of May, nineteen hundred and seventy-three, have approved the following provisions which, subject to the Sanction of Her Most Excellent Majesty in Council, shall have force of law in the Islands of Guernsey, Alderney, Herm and Jethou.

1. Section forty-seven (which relates to the constitution of the Insurance Authority) of the Social Insurance (Guernsey) Law, 1964(a), as amended(b), is hereby further amended as follows, that is to say—

(a) paragraph (b) of subsection (2) thereof is repealed and the following paragraph is substituted therefor—

“(b) six other members (hereafter in this section referred to as “ordinary members”)—

- (i) four of whom shall be members of the States of Deliberation; and
- (ii) two of whom shall not be required to be members of the States of Deliberation.”;

(b) in subsection (11) thereof, the word "three" is repealed and the word "four" is substituted therefor.

Citation and collective title.

2. (1) This Law may be cited as the Social Insurance (Amendment) (Guernsey) Law, 1973.

(2) This Law and the Social Insurance (Guernsey) Laws, 1964 to 1971, may be cited together as the Social Insurance (Guernsey) Laws, 1964 to 1973.

Commencement.

3. This Law shall come into force on such day as shall be appointed in that behalf by Ordinance of the States of Guernsey.
