## The Social Insurance (Rates of Contributions and Benefits, etc.) (Amendments) Ordinance, 1995.

THE STATES LEGISLATION COMMITTEE, in pursuance of the States' Resolution of the 29th day of June, 1995(a) and in exercise of the powers conferred on the States by sections 8 and 101 of the Social Insurance (Guernsey) Law, 1978 as amended(b), and on the Committee by Article 66(3) of the Reform (Guernsey) Law, 1948(c), hereby order:-

### Additional rate of Class 3 contributions.

1. In section 6 of the Social Insurance (Rates of Contributions and Benefits, etc.) Ordinance, 1995(d) (hereinafter called "the Principal Ordinance"), paragraph (c) is relettered "(d)" and the following paragraph is inserted immediately after paragraph (b)-

2. For the table in section 8(e) of the Principal Ordinance there is substituted-

3. This Ordinance shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

**Citation.**

4. This Ordinance may be cited as the Social Insurance (Rates of Contributions and Benefits, etc.) (Amendment) Ordinance, 1995.

**Commencement.**

5. This Ordinance shall come into force on 1st January, 1996.
