**The Social Insurance (Reciprocal Agreement with Great
Britain, Northern Ireland, the Isle of Man and Jersey)
(Guernsey) Ordinance, 1994**

THE STATES, in exercise of the powers conferred upon them by section 113 of the Social Insurance (Guernsey) Law, 1978, as amended(a), hereby order:-

Agreement to have effect

1. (1) The Agreement between the Secretary of State for Social Security, the Department of Health and Social Services for Northern Ireland and the Lieutenant-Governor of the Isle of Man and the Social Security Committee of Jersey and the Guernsey Social Security Authority, registered on the records of the Island of Guernsey on the 3rd day of October, 1994, shall have full force and effect.

(2) The Social Insurance (Guernsey) Law, 1978, as amended, shall have effect subject to such modifications as may be required for the purposes of giving effect to the said Agreement.

Repeals

2. The enactments set out in the Schedule to this Ordinance are repealed.

Extent

3. This Ordinance shall apply to the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

4. This Ordinance may be cited as the Social Insurance (Reciprocal Agreement with Great Britain, Northern Ireland, the Isle of Man and Jersey) (Guernsey) Ordinance, 1994.

Commencement

5. This Ordinance shall be deemed to have come into force on the 2nd day of November, 1994.
