**The Social Insurance (Reciprocal Agreement with the
Republic of Cyprus) (Amendment) (Guernsey) Ordinance,
1994**

THE STATES, in exercise of the powers conferred upon them by section 113 of the Social Insurance (Guernsey) Law, 1978, as amended^a, hereby order:—

Amendment to principal Convention.

1. (1) The provisions contained in an exchange of Notes between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Cyprus dated 9th May 1994 and set out in the Schedule to the Social Security (Cyprus) Order, 1994^b, registered on the records of the Island of Guernsey on the 3rd day of October, 1994, shall have full force and effect.

(2) The Social Insurance (Guernsey) Law, 1978, as amended, and the Convention on Social Security between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Cyprus given full force and effect by the Social Insurance (Reciprocal Agreement with the Republic of Cyprus) (Guernsey) Ordinance, [1978]^c, shall have effect subject to such modifications as may be required for the purpose of giving effect to such Notes.

Extent.

2. This Ordinance shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation.

3. This Ordinance may be cited as the Social Insurance (Reciprocal Agreement with the Republic of Cyprus) (Amendment) (Guernsey) Ordinance, 1994.

Commencement.

4. This Ordinance shall be deemed to have come into force on the 4th day of July, 1994.
