Made 27th September, 1973.
Coming into Operation ... 1st November, 1973.

The Stamp Duty (Repeal) Ordinance, 1973

THE STATES, in pursuance of their Resolution of the twenty-eighth day of April, nineteen hundred and seventy-one, and in exercise of the powers conferred upon them by subsection (1) of section one of the Indirect Taxes, Duties and Impôts (Guernsey) Law, 1962(a), hereby order:—

1. The Ordinances set out in the left-hand column of the Schedule to this Ordinance are hereby repealed to the extent set out in the right-hand column of the said Schedule. Repeal of Stamp Duty Ordinances.
2. This Ordinance may be cited as the Stamp Duty (Repeal) Ordinance, 1973. Citation.
3. This Ordinance shall come into force on the first day of November, nineteen hundred and seventy-three. Commencement.
