**The Supplementary Benefit (Implementation) (Amendment) (No. 2) Ordinance, 1973**

THE STATES, in pursuance of their Resolution of the twenty-seventh day of June, nineteen hundred and seventy-three, and in exercise of the powers conferred upon them by subsection (2) of section three of the Supplementary Benefit (Guernsey) Law, 1971(a), hereby order:—

1. Paragraph 5 of Part II of the First Schedule to the Supplementary Benefit (Implementation) Ordinance, 1971 (hereinafter referred to as “the principal Ordinance”)(b), as amended(c), is hereby repealed and the following paragraph is substituted therefor—

*“Normal requirements*

5. The requirements of persons shall be as follows, that is to say:—

(c) Recueil d'Ordonnances Tome XVII, p. 179; Ordinance No. XXXIII and No. XLI of 1972 and No. IX of 1973.

- (a) For a husband and wife or other persons falling within sub-paragraph (1) of paragraph 2 of this Schedule ... .. £11.95
- (b) For a person living alone or a householder not falling within item (a) of this paragraph who is directly responsible for household necessities and rent (if any) ... £7.50
- (c) For any other person—
- (i) aged twenty years or over ... £6.25
  - (ii) aged eighteen years or over but less than twenty years ... £4.95
  - (iii) aged sixteen years or over but less than eighteen years ... £4.40
  - (iv) aged thirteen years or over but less than sixteen years ... £3.70
  - (v) aged eleven years or over but less than thirteen years ... £3.00
  - (vi) aged five years or over but less than eleven years ... £2.45
  - (vii) aged less than five years ... £2.05”.

**Repeal.**

2. The Supplementary Benefit (Implementation) (Amendment) Ordinance, 1973, is hereby repealed.

**Citation.**

3. This Ordinance may be cited as the Supplementary Benefit (Implementation) (Amendment) (No. 2) Ordinance, 1973.

**Collective title.**

4. This Ordinance, the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1972, the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1971, and the principal Ordinance may be cited together as the Supple-

mentary Benefit (Implementation) Ordinances, 1971 to 1973.

5. This Ordinance shall come into force on the Commencement<sup>ment</sup> ninth day of November, nineteen hundred and seventy-three.
