**The Supplementary Benefit (Implement-
ation) (Amendment) (No. 2)
Ordinance, 1977**

THE STATES, in pursuance of their Resolution of the twenty-seventh day of July, nineteen hundred and seventy-seven, and in exercise of the powers conferred upon them by subsection (2) of section three of the Supplementary Benefit (Guernsey) Law, 1971(a), hereby order:—

1. The Supplementary Benefit (Implementation) Ordinance, 1971(b), as amended(c), is hereby further amended as follows, that is to say:—

5. The requirements of persons shall be as follows, that is to say:—

| (vi) aged five years or over but less than eleven years ... | £5.00 |

(b) in sub-paragraph (1) of paragraph 15 of Part III of the First Schedule thereto, the words “four pounds” are hereby repealed and the words “six pounds” are hereby substituted therefor.

2. The Supplementary Benefit (Implementation) (Amendment) (No. 2) Ordinance, 1975, the Supplementary Benefit (Implementation) (Amendment) (No. 2) Ordinance, 1976, and the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1977, are hereby repealed.

3. (1) This Ordinance may be cited as the Supplementary Benefit (Implementation) (Amendment) (No. 2) Ordinance, 1977.
