1985

Made 27th November, 1985.
Coming into Operation ... 6th January, 1986.

The Supplementary Benefit (Implementation) (Amendment) (No.2) Ordinance, 1985

THE STATES, in pursuance of their Resolution of the 26th day of January, 1983, and in exercise of the powers conferred upon them by section 3(2) of the Supplementary Benefit (Guernsey) Law, 1971(a), hereby order:—

1. Part III of the First Schedule to the Supplementary Benefit (Implementation) Ordinance, 1971, as amended(b), is hereby further amended as follows:—

(a) sub-paragraph (3) of paragraph 15 thereof is repealed and the following sub-paragraph is substituted therefor—

“(3) For the purposes of this Schedule, there shall be included in a person’s net weekly earnings—

- (i) the cash value of any board or lodging or both which he is enjoying under and in pursuance of a contract of service;
 - (ii) any invalid care allowance payable in accordance with the Attendance and Invalid Care Allowances (Guernsey) Law, 1984.”;
- (b) the full stop at the end of item (b) of paragraph 16 thereof is deleted and a semi-colon is substituted therefor and immediately thereafter there is inserted the following additional item lettered “(c)”—

“(c) any attendance allowance granted under the Attendance and Invalid Care Allowances (Guernsey) Law, 1984.”.

- Repeal. 2. Section 5 of the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1985(c) is hereby repealed.
- Extent. 3. This Ordinance shall have effect in the Islands of Guernsey, Herm and Jethou.
- Citation. 4. This Ordinance may be cited as the Supplementary Benefit (Implementation) (Amendment) (No. 2) Ordinance, 1985.
- Collective title. 5. This Ordinance, the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1985, and the Supplementary Benefit (Implementation) Ordinances, 1971 to 1982, may be cited together as the Supplementary Benefit (Implementation) Ordinances, 1971 to 1985.

6. This Ordinance shall come into force on the 6th day of January, 1986. ^{Commence-}
