**The Supplementary Benefit
(Implementation) (Amendment) Ordinance,
1971**

THE STATES, in pursuance of their Resolution of the thirtieth day of June, nineteen hundred and seventy-one, and in exercise of the powers conferred upon them by subsection (2) of section three of the Supplementary Benefit (Guernsey) Law, 1971(a), and of all other powers enabling them in that behalf, hereby order:—

1. The First Schedule to the Supplementary Benefit (Implementation) Ordinance, 1971(b), is hereby amended as follows:— Amend-
ment and
repeals.

- (a) the proviso to sub-paragraph (1) of paragraph 3 of Part I thereof is hereby repealed;
- (b) paragraph 5 of Part II thereof is hereby repealed and the following paragraph is hereby substituted therefor—

(a) No. II of 1971.
(b) No. XXXVIII of 1971.

“Normal requirements

5. The requirements of persons shall be as follows, that is to say:—

- (c) item (b) of paragraph 11 of Part III thereof is hereby repealed;
- (d) the full stop at the end of item (d) of subparagraph (1) of paragraph 17 of Part III thereof is hereby deleted and a semi-colon is hereby substituted therefor and immediately thereafter there is hereby inserted the following additional item lettered “(e)”—

“(e) any allowance payable under the Family Allowances (Guernsey) Law, 1950.”.

2. This Ordinance may be cited as the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1971. Citation.

3. This Ordinance shall come into force on the tenth day of September, nineteen hundred and seventy-one. Commence-
ment.
