Coming into Operation ... 27th May, 1977.

The Supplementary Benefit (Implementation) (Amendment) Ordinance, 1977

THE STATES, in pursuance of their Resolution of the thirtieth day of March, nineteen hundred and seventy-seven, and in exercise of the powers conferred upon them by subsection (2) of section three of the Supplementary Benefit (Guernsey) Law, 1971(a), hereby order:—

1. Paragraph 5 of Part II of the First Schedule to the Supplementary Benefit (Implementation) Ordinance, 1971(b), as amended(c), is hereby repealed and the following paragraph is hereby substituted therefor—

“Normal requirements

5. The requirements of persons shall be as follows, that is to say:—

(3) This Ordinance shall come into force on the twenty-seventh day of May, nineteen hundred and seventy-seven.
