### **The Supplementary Benefit (Implementation) (Amendment) Ordinance, 1978**

THE STATES, in pursuance of their Resolution of the twenty-first day of June, nineteen hundred and seventy-eight, and in exercise of the powers conferred upon them by subsection (2) of section three of the Supplementary Benefit (Guernsey) Law, 1971(a), hereby order:—

1. The Supplementary Benefit (Implementation) Ordinance, 1971(b), as amended(c), is hereby further amended as follows, that is to say:— Amend.

- (a) sub-paragraph (2) of paragraph 3 of Part I of the First Schedule thereto is hereby repealed and the following sub-paragraph is hereby substituted therefor—

“(2) For the purposes of the last preceding sub-paragraph the limit of weekly income shall be £54.50.”

- (b) paragraph 5 of Part II of the First Schedule thereto is hereby repealed and the following paragraph is hereby substituted therefor—

“*Normal requirements*

5. The requirements of persons shall be as follows, that is to say:—

(a) For a husband and wife or other persons falling within sub-paragraph (1) of paragraph 2 of this Schedule ... .. £32.30

(b) For a person living alone or a householder not falling within item (a) of this paragraph who is directly responsible for household necessities and rent (if any) ... .. £20.30

(c) For any other person—

(i) aged twenty years or over ... .. £16.80

(ii) aged eighteen years or over but less than twenty years ... .. £10.90

(iii) aged sixteen years or over but less than eighteen years ... .. £9.75

(iv) aged thirteen years or over but less than sixteen years ... .. £8.35

- (v) aged eleven years or over but less than thirteen years ... £6.80
- (vi) aged five years or over but less than eleven years ... £5.50
- (vii) aged less than five years ... .. £4.50”

2. Paragraph (a) of section one of the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1977, is hereby repealed. Repeals

3. (1) This Ordinance may be cited as the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1978. Citation collective title and commencement.

(2) This Ordinance and the Supplementary Benefit (Implementation) Ordinances, 1971 to 1977, may be cited together as the Supplementary Benefit (Implementation) Ordinances, 1971 to 1978.

(3) This Ordinance shall come into force on the twenty-fourth day of November, nineteen hundred and seventy-eight.
