## Ordinance of the States **XV**

**1979**

Made ... .. 25th July, 1979.  
Coming into Operation ... 23rd November, 1979.

### **The Supplementary Benefit (Implementation) (Amendment) Ordinance, 1979**

THE STATES, in pursuance of their Resolution of the twenty-seventh day of June, nineteen hundred and seventy-nine, and in exercise of the powers conferred upon them by subsection (2) of section three of the Supplementary Benefit (Guernsey) Law, 1971(a), hereby order:—

1. The Supplementary Benefit (Implementation) Ordinance, 1971(b), as amended(c), is hereby further amended as follows, that is to say:—

- (a) sub-paragraph (2) of paragraph 3 of Part I of the First Schedule thereto is hereby repealed and the following sub-paragraph is hereby substituted therefor—

“(2) For the purposes of the last preceding sub-paragraph the limit of weekly income shall be £58.00.”;

- (b) paragraph 5 of Part II of the First Schedule thereto is hereby repealed and the following paragraph is hereby substituted therefor—

*“Normal requirements*

5. The requirements of persons shall be as follows, that is to say:—

2. The Supplementary Benefit (Implementation) (Amendment) Ordinance, 1978, is hereby repealed. **Repeal.**

3. (1) This Ordinance may be cited as the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1979. **Citation, collective title and commencement.**

(2) This Ordinance and the Supplementary Benefit (Implementation) Ordinances, 1971 to 1977, may be cited together as the Supplementary Benefit (Implementation) Ordinances, 1971 to 1979.

(3) This Ordinance shall come into force on the twenty-third day of November, nineteen hundred and seventy-nine.
