

GUERNSEY STATUTORY INSTRUMENT2012 NO. 12**The Parking Places (Amendment) Order, 2012**Made First March 2012Coming into operation 9th March 2012

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended¹, hereby orders:-

1. The Parking Places Order, 1991, as amended², is further amended as follows.
2. In Part C of Schedule 1, in the third column relating to Disc Parking Place No. DC8 (Pedvin Street), for "Place No. AB10" substitute "Places Nos. AB10 and AC60".
3. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. –

- (a) AA1 (New Place, Vauvert), for "Place Nos. AC1c and AC54" substitute "Place Nos. AC1c, AC14 and AC63",
- (b) AA5 (Route Isabelle), delete "but excluding Approved Parking Place No. AC17a",
- (c) AA7 (Stanley Road), insert "but excluding Approved Parking Place No. AC61" after the words "south side of the road",
- (d) AA11a (Gibauderie), for "Place No. AC36" substitute "Places Nos. AC36 and AC59",
- (e) AA41 (Mahaut Gardens), insert "On the north side of the road within the limits indicated by signs but excluding Approved Parking Place No. AC62.",
- (f) AA57 (Rue Jehannet), for ", AC21, AC26 and AC30" substitute "and AC26", and
- (g) AA69 (Les Genats), delete "AC7b".

4. In Part C of Schedule 2, delete the entries relating to Approved Parking Places Nos. AC7b, AC12, AC17a, AC21 and AC30.

5. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC58 insert the following entry –

"AC59	Gibauderie	The portion of the south side of the road as near as practical to the property known as 'Potosi', 5 Tunstall Terrace, within the limits indicated by signs as being reserved for persons in possession of a disabled persons badge.
AC60	Pedvin Street	The portion of the north side of the road as near as practical to the property known as 'Anfield', within the limits indicated by signs as being reserved for persons in possession of a disabled persons badge.
AC61	Stanley Road	The portion of the south side of the road as near as practical to the property known as 'La Reste', within the limits indicated by signs as being reserved for persons in possession of a disabled persons badge.
AC62	Mahaut Gardens	The portion of the north side of the road as near as practical to property No. 28, within the limits indicated by signs as being reserved for persons in possession of a disabled persons badge.

AC63	New Place	The portion of the south side of the road as near as practical to the property known as 'La Cachette', within the limits indicated by signs as being reserved for persons in possession of a disabled persons badge."

6. This Order may be cited as the Parking Places (Amendment) Order, 2012.
7. This Order shall come into force on the 9th March 2012.
