**The Health Service (Benefit) (Limited List) (Pharmaceutical  
Benefit) (Amendment) (No.2) Regulations, 2012**

**THE SOCIAL SECURITY DEPARTMENT**, in exercise of the powers conferred upon it by sections 10 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990 as amended<sup>a</sup>, section 1 of the Health Service (Benefit) (Limited Lists) Ordinance, 2004<sup>b</sup> and of all other powers enabling it in that behalf, hereby orders:-

**Amendment.**

1. In the Schedule to the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) Regulations, 2004<sup>c</sup>, as amended;

**Interpretation.**



**Citation, commencement and extent.**

3. (1) These Regulations may be cited as the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) (Amendment) (No.2) Regulations, 2012 and shall come into force on the 29<sup>th</sup> day of May 2012.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

4.9	Drugs used in parkinsonism and related disorders	Ropinirole modified release tablets 2mg, 4mg, 8mg
11.6	Treatment of glaucoma	Travoprost eye drops 40 micrograms/ml (Specialist initiation/recommendation only)

## EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport)

These Regulations add to and remove from the limited list of drugs and medicines available as pharmaceutical benefit which may be ordered to be supplied by medical prescriptions issued by medical practitioners.

These Regulations came into operation on 29<sup>th</sup> May 2012.
