

**The Health Service (Benefit) (Limited List) (Pharmaceutical  
Benefit) (Amendment) (No.3) Regulations, 2012**

**THE SOCIAL SECURITY DEPARTMENT**, in exercise of the powers conferred upon it by sections 10 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990 as amended<sup>a</sup>, section 1 of the Health Service (Benefit) (Limited Lists) Ordinance, 2004<sup>b</sup> and of all other powers enabling it in that behalf, hereby orders:-

**Amendment.**

1. In the Schedule to the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) Regulations, 2004<sup>c</sup>, as amended add the rows set out in Schedule 1 to these Regulations, under the appropriate headings.

2. The Interpretation (Guernsey) Law, 1948<sup>d</sup> applies to the interpretation of these Regulations as it applies to the interpretation of a Guernsey enactment.

**Citation, commencement and extent.**

3. (1) These Regulations may be cited as the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) (Amendment) (No.3) Regulations, 2012 and shall come into force on the 10<sup>th</sup> day of July 2012.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.
