

The Parking Places (Amendment) Order, 1975

Made the 31st day of May, 1975.

Coming into force on the 4th day of June, 1975.

THE ISLAND POLICE COMMITTEE, in pursuance of the powers vested in it by section one of the Road Traffic (Parking Places) Ordinance, 1963(a), and of all other powers enabling it in that behalf, hereby orders:-

1. The Parking Places Order, 1968, as amended(b), is hereby further amended as follows:-

- (a) in section six thereof the word, letters and figures "A7 or A49" are repealed and the word, letters and figures "A7, A49 or A50" are substituted therefor;
- (b) in paragraph (a) of section nine thereof the words, letter and figures "in disc parking place No. D21" are repealed and the words, letters and figures "in disc parking places Nos. D21 and D92" are substituted therefor;
- (c) in paragraph (c) of section nine thereof the word, letters and figures "D84 and D85" are repealed and the word, letters and figures "D85, D89 and D90" are substituted therefor;
- (d) in paragraph (d) of section nine thereof -
  - (i) the letters and figures "D32" and "D77" respectively are repealed;
  - (ii) the word, letters and figures "D78 and D79" are repealed and the word, letters and figures "D78, D79 and D91" are substituted therefor;
- (e) in sub-paragraph (i) of paragraph (f) of section nine thereof the words "one hundred and twenty minutes" are repealed and the words "thirty minutes" are substituted therefor;
- (f) in paragraph (g) of section nine thereof the word, letters and figures "D80, D81, D82, D83 and D88" are repealed and the word, letters and figures "D77, D80, D81, D82, D83, D84, D88, D93, and D94" are substituted therefor;
- (g) the entries relating to disc parking place No. D32 in each of the columns of Part I of the First Schedule thereto are repealed;
- (h) the entry relating to disc parking place No. D.33 in the third column of Part I of the First Schedule thereto is repealed and the entry "The east side of the road between a parking sign placed as near as may be to the house numbered 12 and a parking sign placed as near as may be to the premises known as Melbourne House." is substituted therefor;
- (i) the entry relating to disc parking place No. D46 in the third column of Part I of the First Schedule thereto is repealed and the entry "The southern side of the road between a parking sign placed as near as may be to the eastern end of the plantation and a parking sign placed as near as may be to the centre of the plantation." is substituted therefor;

- (j) the entry relating to disc parking place No. D51 in the third column of Part I of the First Schedule thereto is repealed and the entry "The landward side of the road between a parking sign placed as near as may be to the premises known as the Foresters' Arms and a parking sign placed as near as may be to its junction with Bouillon Lane." <sup>is</sup> ~~are~~ substituted therefor; *Ad. R.J.*
- (k) immediately after the entries relating to disc parking place No. D88 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the First Schedule to this Order;
- (l) immediately after the entries relating to approved parking place No. A49 in each of the columns of Part II of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Second Schedule to this Order;
- (m) the entry relating to approved parking place No. MB11 in the third column of Part III of the First Schedule thereto is repealed and the entry "The portion of the southern side of the road near the centre of the plantation indicated by parking signs as being reserved for motor bicycles." <sup>is substituted therefor</sup> ~~is~~ substituted therefor. *Ad. R.J.*
2. This Order may be cited as the Parking Places (Amendment) Order, 1973.
3. This Order shall come into force on the fourth day of June, nineteen hundred and seventy-three.

"D89	Arsenal Road, Saint Peter Port.	The southern side of the road between a parking sign placed as near as may be to the centre of the plantation and a parking sign placed as near as may be to its junction with Brock Road.
D90	La Valette, Saint Peter Port.	The east side of the road within the limits indicated by parking signs.
D91	Vale Avenue, Vale.	The east side of the road between a parking sign placed as near as may be to its junction with Bridge Road and a parking sign placed as near as may be opposite its northern junction with Hougue du Valle Road.
D92	Pollet Street, Saint Peter Port.	The east side of the road between a parking sign placed as near as may be to its junction with Le Truchot and a parking sign placed as near as may be to its junction with La Tourgand
D93	Upper Saint Jacques, Saint Peter Port.	The east side of the road between a parking sign placed as near as may be to its junction with Gibauderie and a parking sign placed as near as may

D94	Les Canichers, Saint Peter Port.	The west side of the road between a parking sign placed as near as may be to the house known as Ivy Green and a parking sign placed as near as may be to its junction with Les Amballes Road."
