

THE IMPORT DUTIES (BAILLIWICK OF GUERNSEY) (NO. 63) ORDER, 1973

THE BOARD OF ADMINISTRATION, in pursuance of the powers conferred upon it by section two and section ten of the Import Duties Act (Bailiwick of Guernsey) 1932, as amended and in implementation of the obligations of the Bailiwick under the provisions of Protocol No. 3 annexed to the Treaty relating to the accession of the United Kingdom to the European Economic Community and to the European Atomic Energy Community, hereby orders:-

1. The Import Duties (Bailiwick of Guernsey) (No. 61) Order, 1973 (a) is hereby amended as follows:-
 - (a) for sub-paragraph (ii) of paragraph (d) of subsection (1) of section three thereof there shall be substituted the following sub-paragraphs:-
 - "(ii) where the goods (not being goods falling within sub-paragraph (i) above) satisfy the requirements of the Free Trade Agreements, being goods other than those of headings 05.08 B., 05.08 C., 05.09, 16.02 A.I.a), 16.02 B.II.a)1., 16.02 B.III.b)1.aa)11., 16.02 B.III.b)2.aa)11.aaa), 16.02 B.III.b)2.bb)11.aaa), 16.05 A.*, 16.05 B.I., 21.06 A.I., 21.06 A.III. and 22.10 where a rate is shown in the third column prefixed by the letter "M", duty shall be charged at that rate; and
 - (iii) where goods falling within headings 07.01 A.II.a) and 07.05 A.I. satisfy the origin conditions in Portugal duty shall be charged at the rate shown in the third column prefixed by the letter "M";";
 - (b) the following footnote shall be inserted in respect of the said sub-paragraph (ii) thereof as substituted:-

"*The "M" rate may, however, be claimed for goods of subheadings marked with this symbol which satisfy the origin conditions in Portugal.";
 - (c) for paragraph (b) of section six thereof shall be substituted the following:-

"(b) until (and on) such day as is referred to in rule (a), the unit of account shall be taken as equal to £0.46202.";
 - (d) in the third column (headed "Preferential") of the Second Schedule thereto there shall be inserted immediately before the rate of duty shown in respect of each tariff heading set out in the First Schedule to this Order, the rate of duty set out opposite to such tariff heading in the said First Schedule, prefixed by the letter "M";
 - (e) the Second Schedule thereto shall be amended as shown in the Second Schedule to this Order.
2. The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.

3. (1) This Order may be cited as the Import Duties (Bailiwick of Guernsey)(No. 63) Order, 1973.
- (2) This Order shall come into operation on the first day of July, nineteen hundred and seventy-three.

SECOND SCHEDULE

1. The existing Additional Note to Chapter 2 shall be numbered 1. and the following Additional Notes inserted:
 - "2. A. For the purposes of subheadings 02.06 B.I.a)2,aa) and 02.06 B.I.b)2,aa), "bacon sides" shall be taken to mean pig half-carcases without the head, chaps, neck, feet, tail, flare fat, kidneys, tenderloin, blade bone, sternum, vertebral column, pelvic bone and diaphragm;
 - B. For the purposes of subheadings 02.06 B.I.a)2,bb) and 02.06 B.I.b)2,bb), "spencers" shall be taken to mean "bacon sides" without the ham, whether or not boned;
 - C. For the purposes of subheadings 02.06 B.I.a)2,cc) and 02.06 B.I.b)2,cc), " $\frac{3}{4}$ sides" shall be taken to mean "bacon sides" without the shoulder, whether or not boned;
 - D. For the purposes of subheadings 02.06 B.I.a)2,cc) and 02.06 B.I.b)2,cc), "middles" shall be taken to mean "bacon sides" without the ham and the shoulder, whether or not boned.
 3. For the purposes of subheadings 02.06 B.I.b)3,aa),4,aa), 5,aa), 6,aa) and 7,aa), products whose water/protein ratio in the meat (nitrogen content multiplied by 6.25) is more than 2.8 shall be considered as slightly dried and slightly smoked."
- and in consequence "Additional Note" shall be altered to the plural.

2. The following footnote shall be inserted on page 9:

"* In certain conditions a levy is applicable."

3. Subheading 02.02 A.II.b) shall be deleted and the following substituted therefor:

"b) Plucked and drawn, without heads and feet, but with hearts, livers and gizzards, known as "70% ducks"."

4. After subheading 02.02 A.II.b) there shall be inserted the following new subheading and rates of duty:

12. In subheading 04.04 E.I.b)2., after the word "Tilsit" there shall be inserted the words "and Butterkäse".

13. There shall be inserted the symbol " † " against subheading 04.05 B., together with the following footnote: " † Note. - For albumin see heading 35.02."

14. The symbol " * " against subheading 07.01 A. shall be deleted. The symbol " * " shall be inserted against subheading 07.01 A.I.

15. In subheading 07.04 B.II. there shall be inserted the letter "C" before the word "Free" in the third column.

16. There shall be inserted the symbol " * " against subheadings 16.02 B.I.a) and b), together with the following footnote: "* For the purpose of determining the percentage of poultry meat, the weight of any bones is to be disregarded."

17. In subheading 16.02 B.III.b)1.a)11. there shall be inserted the symbol " * " against the "E" rate of duty shown in the third column, together with the following footnote: " * Rate for Denmark - Free."
