

The Road Traffic (Prohibited and One-Way Streets) (No. 2)  
Regulations, 1973

Made the 17th day of October, 1973

Coming into operation on the 20th day of October, 1973

THE ISLAND POLICE COMMITTEE, in pursuance of the powers conferred upon it by Article X of the Ordinance entitled "Ordonnance relative au Trafic Véhiculaire en cette Ile" of the second day of March, nineteen hundred and twenty-nine (a), and the Traffic Temporary Regulations Ordinance, 1950 (b), and of all powers enabling it in that behalf, hereby makes the following Regulations in order to ascertain the best method of regulating traffic in this Island:-

1. A person being in charge of a vehicle or an animal shall not, without the permission of the Chief Officer, drive or ride that vehicle or cause or permit that animal to proceed on or along:-

- (a) Fosse André, Saint Peter Port, from its junction with La Butte to its junction with Coronation Road, otherwise than from east to west;
- (b) Coronation Road, Saint Peter Port, otherwise than from north to south;
- (c) Rouge Huis Avenue, Saint Peter Port, otherwise than from north to south.

2. (1) In these Regulations, unless the context otherwise requires, the following expressions have the meanings respectively assigned to them:-

"animal" and "vehicle" have the meanings assigned to them by Article I of the Ordinance entitled "Ordonnance relative au Trafic Véhiculaire en cette Ile" of the second day of March, nineteen hundred and twenty-nine;

"Chief Officer" means the Chief Officer of the Island Police Force.

(2) Except where the context otherwise requires, any reference in these Regulations to any other enactment shall be construed as a reference to that enactment as amended, repealed and replaced, extended or applied by or under any other enactment including these Regulations.

3. These Regulations may be cited as the Road Traffic (Prohibited and One-Way Streets) (No. 2) Regulations, 1973.

4. These Regulations shall come into force on the twentieth day of October, nineteen hundred and seventy-three, and shall continue in force until the nineteenth day of April, nineteen hundred and seventy-four.

EXPLANATORY NOTE

(This Note forms no part of the Regulations but is intended to indicate their general purport)

The effect of these Regulations is that for a period of six months from the 20th October, 1973:-

- (a) Fosse André, Saint Peter Port, from its junction with La Butte to its junction with Coronation Road, will continue to be a one-way street, traffic being required to proceed in the direction of its junction with Coronation Road;
- (b) Coronation Road, Saint Peter Port, will continue to be a one-way street, traffic being required to proceed in the direction of Elm Grove;
- (c) Rouge Huis Avenue, Saint Peter Port will also continue to be a one-way street, traffic now being required to proceed in the direction of Brock Road.
