

The Post Office (British Commonwealth and Foreign Parcel Post)  
(Amendment) Order, 1971

Made .....5th February, 1971,

Coming into operation .....15th February, 1971.

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections sixteen, eighteen, nineteen, twenty-eight and sixty-eight of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

Amendment to section nine of the Order of 1969.

1. In paragraph (a) of subsection (3) of section nine of the Post Office (British Commonwealth and Foreign Parcel Post) Order, 1969 (hereinafter referred to as "the principal Order")(b), the words "four pence" are hereby repealed and the figures and letter "1.5p" are hereby substituted therefor.

Amendments to section thirteen of the Order of 1969.

2. Section thirteen of the principal Order is hereby amended as follows:-

(a) in paragraph (a) of subsection (1) thereof the words "nine pence" and "one shilling" are repealed and the words "four new pence" and "five new pence" are respectively substituted therefor;

(b) in paragraph (b) of subsection (1) thereof the words "three pence" are repealed and the words "one new penny" are substituted therefor;

(c) in subsection (2) thereof the words "one shilling" are repealed and the words "five new pence" are substituted therefor.

New Schedules to Order of 1969.

3. The First and Second Schedules to the principal Order are hereby repealed and the Schedules set out in the First and Second Schedules to this Order are hereby respectively substituted therefor.

Citation.

4. This Order may be cited as the Post Office (British Commonwealth and Foreign Parcel Post) (Amendment) Order, 1971.

Commencement

5. This Order shall come into force on the fifteenth day of February, nineteen hundred and seventy-one.
