

The Family Allowances, Social Insurance and Non-Contributory
Pensions (Decimalisation of the Currency) (Amendment) (Guernsey) Regulations,
1971

Made 28th May, 1971
Laid before the States 1971
Coming into operation .. 7th June and 11th June, 1971

THE STATES ADVISORY AND FINANCE COMMITTEE, in exercise of the powers conferred upon it by section nine of the Decimal Currency (Bailiwick of Guernsey) Law, 1970, hereby orders:-

Amendments to Regulations of 1971

1. The Family Allowances, Social Insurance and Non-Contributory Pensions (Decimalisation of the Currency) (Guernsey) Regulations, 1971, are hereby amended as follows:-

- (a) in paragraph (1) of regulation one thereof the definition of the the expression "Non-Contributory Pensions Law" is repealed and the following definition is substituted therefor -
"the Supplementary Benefit Law" means the Supplementary Benefit (Guernsey) Law, 1971;";
- (b) in paragraph (2) of regulation two thereof the words "a pension under the Non-Contributory Pensions Law" are repealed and the words "a supplementary benefit under the Supplementary Benefit Law" are substituted therefor;
- (c) regulations five and eight thereof are hereby repealed;
- (d) in paragraph (4) of regulation eleven thereof the words "a pensio under the Non-Contributory Pensions Law," are repealed and the wor "a supplementary benefit under the Supplementary Benefit Law" are substituted therefor;
- (e) the First and Third Schedules thereto are hereby repealed.

Citation and Commencement

2.(1) These Regulations may be cited as the Family Allowances, Social Insurance and Non-Contributory Pensions (Decimalisation of the Currency) (Amendment) (Guernsey) Regulations, 1971.

(2) Paragraphs (c) and (e) of regulation one of these Regulations shall come into force on the seventh day of June, nineteen hundred and seventy-one.

(3) Paragraphs (a), (b) and (d) of regulation one of these Regulations shall come into force on the eleventh day of June, nineteen hundred and seventy-one.

EXPLANATORY NOTE

(This Note is not part of the Regulations but is
intended to indicate their general purport.)

These Regulations amend the Family Allowances, Social Insurance and Non-Contributory Pensions (Decimalisation of the Currency) (Guernsey) Regulations, 1971, and are consequential upon the coming into force of the Social Insurance (Amendment) (Guernsey) Law, 1971, and the Supplementary Benefit (Guernsey) Law, 1971, and the subordinate legislation made thereunder.
