The Social Insurance (Pensions, Existing Contributors)  
(Transitional) (Amendment) (Guernsey) Regulations, 1971.

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section seventy-two, section seventy-five and section seventy-seven of the Social Insurance (Guernsey) Law, 1964, as amended, and of all other powers enabling it in that behalf, hereby orders:-

Amendments to regulation four of the principal regulations.

1. Paragraph (1) of regulation four of the Social Insurance (Pensions, Existing Contributors) (Transitional) (Guernsey) Regulations, 1964, (hereinafter referred to as "the principal regulations") is hereby repealed and the following paragraph is hereby substituted therefor:-

"(1) Subject to the succeeding provisions of this regulations the insurance under the Contributory Pensions Laws of an existing contributor shall be treated as insurance under the Law for the purposes of widow's benefit, a child's special allowance and an old age pension including an old age pension for a widow by virtue of her husband's insurance."

Amendments to regulation five of the principal regulations.

2. In regulation five of the principal regulations:-
  - (a) the words "a retirement pension" or "retirement pension" wherever those words occur are hereby repealed and the words "an old age pension" and "old age pension" are hereby respectively substituted therefor;
  - (b) paragraph (13) thereof is hereby repealed.

Amendment to regulation seven of the principal regulations.

3. In regulation seven of the principal regulations, immediately after the word "benefit" there are hereby inserted the words "other than death grant".

Amendment to regulation eight of the principal regulations.

4. Regulation eight of the principal regulations is hereby amended as follows:-
- (a) in sub-paragraph (a) of paragraph (1) thereof the words "a retirement pension" are hereby repealed and the words "an old pension" are hereby substituted therefor,
  - (b) sub-paragraph (c) of paragraph (2) thereof is hereby repealed.

Repeal of regulation nine of the principal regulations.

5. Regulation nine of the principal regulations is hereby repealed.

Repeal of Schedule to the principal regulations.

6. The Schedule to the principal regulations is hereby repealed.

Amendments to the Increase of Benefit and Miscellaneous Provisions Regulations.

7. Regulation seven of the Social Insurance (Increase of Benefit and Miscellaneous Provisions) (Guernsey) Regulations, 1967, and the Ninth Schedule thereto are hereby repealed.

Citation and commencement.

8. (1) These regulations may be cited as the Social Insurance (Pensions, Existing Contributors) (Transitional) (Amendment) (Guernsey) Regulations, 1971, and these regulations and the Social Insurance (Pensions, Existing Contributors) (Transitional) (Guernsey) Regulations, 1964 and 1968, may be cited together as the Social Insurance (Pensions, Existing Contributors) (Transitional) (Guernsey) Regulations, 1964 to 1971.
- (2) These regulations shall come into operation on the seventh day of June, nineteen hundred and seventy-one.

EXPLANATORY NOTE

(This Note is not part of the Regulations but is intended to indicate their general purport).

These Regulations amend the Social Insurance (Pensions, Existing Contributors) (Transitional) (Guernsey) Regulations, 1964 and 1968; the provisions are consequential upon the amendments to the Social Insurance (Guernsey) Law, 1964 by the Social Insurance (Amendment) (Guernsey) Law, 1971.
