

The Parking Places (Amendment) (No. 2) Order, 1971

Made the 15th day of July, 1971

Coming into force on the 19th day of July, 1971.

THE ISLAND POLICE COMMITTEE, in pursuance of the powers vested in it by section one of the Road Traffic (Parking Places) Ordinance, 1963 (a) and of all other powers enabling it in that behalf, hereby orders:-

1. The Parking Places Order, 1968, as amended (b), is hereby further amended as follows:-

- (a) in section six thereof the word, letters and figures "A6 or A7" are repealed and the word, letters and figures "A6, A7 or A49" are substituted therefor;
- (b) in subsection (3) of section eight thereof the word, letters and figures "A6 or A7" are repealed and the word, letters and figures "A6, A7 or A49" are substituted therefor;
- (c) in paragraph (b) of section nine thereof the word, letters and figures "D28 and D57" are repealed and the word, letters and figures "D28, D57, D86 and D87" are substituted therefor;
- (d) in paragraph (c) of section nine thereof immediately after the letter and figure "D2" there are inserted the letter and figure "D4" and the word, letters and figures "D70 and D71" are repealed and the words, letters and figures "D70, D71, D84 and D85" are substituted therefor;
- (e) in paragraph (d) of section nine thereof the letter and figure "D3" are repealed;
- (f) in paragraph (g) of section nine thereof the word, letters and figures "D4" and "D82 and D83" are repealed and the word, letters and figures "D3" and "D82, D83 and D88" are respectively substituted therefor;
- (g) the entries relating to disc parking place No. D2 in the second and third columns of Part I of the First Schedule thereto are repealed and the entries "Saint James Street, Saint Peter Port" and "The north side of Saint James Street between a parking sign placed as near as may be opposite its junction with New Street to a parking sign placed as near as may be to its eastern end." are respectively substituted therefor;
- (h) the entry relating to disc parking place No. D63 in the third column of Part I of the First Schedule thereto is repealed and the entry "The north side of the road between a parking sign placed as near as may be to the lay-by adjacent to the premises of Maison Grut and a parking sign placed as near as may be to the premises known as Croix Guerin." is substituted therefor;
- (i) in the entry relating to disc parking place No. D71 in the third column of Part I of the First Schedule thereto the words "The south side of the road" are repealed and the words "The east side of the road" are substituted therefor;

- (j) immediately after the entries relating to disc parking place No. D83 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the First Schedule to this Order;
- (k) the entries relating to approved parking place No. A40 in each of the columns of Part II of the First Schedule thereto are repealed;
- (l) immediately after the entries relating to approved parking place No. A.48 in each of the columns of Part II of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Second Schedule to this Order.

2. This Order may be cited as the Parking Places (Amendment) (No.2) Order, 1971.

3. This Order shall come into force on the nineteenth day of July, nineteen hundred and seventy-one.

FIRST SCHEDULE

Section one.

"D84 Ann's Place,  
Saint Peter Port

The south side of the road between a parking sign placed as near as may be opposite the entrance to the Old Government House Hotel and a parking sign placed as near as may be to its eastern end.

D85 North Side,  
Vale

The north side of the road between a parking sign placed as near as may be to its junction with Bridge Road and a parking sign placed as near as may be to the Old Power Station

D86 Trinity Square,  
Saint Peter Port.

The west side of the square between parking signs.

D87 Trinity Square,  
Saint Peter Port.

The south side of the square between parking signs.

D88 Avenue Saint Germain  
and Ruelle Braye, Saint  
Peter Port.

The areas between the two roads at their junction with the Ville au Roi."

SECOND SCHEDULE

Section one.

"A49 Bridge Road,  
Saint Sampson.

The portion of the east side of the road between the southern extremity of disc parking place No. D72 and the western extremity of approved parking place No. MB14 indicated by parking signs as being reserved for public vehicles standing or plying for hire."
