The Milk (Wholesale Prices) (Guernsey) Order, 1969.

THE STATES DAIRY COMMITTEE, in exercise of the powers conferred upon it by subsection (1) and subsection (3) of section six of the Milk (Control) (Guernsey) Ordinance, 1958, as amended, and of all other powers thereunto enabling it, hereby orders:-

1. During the twelve months commencing on the first day of July, nineteen hundred and sixty-nine (hereafter in this Order referred to as "the prescribed period"), the standard price payable by the States Dairy Committee (hereafter in this Order referred to as "the Committee") in respect of Grade 1 milk delivered to the Committee under the provisions of the Milk (Control) (Guernsey) Ordinance, 1958 (hereafter in this Order referred to as "the Ordinance"), during the prescribed period which is not surplus to the Island's milk requirements shall be three shillings, two pence and three farthings.

2. During the prescribed period the price per pot payable by the Committee in respect of milk delivered to the Committee under the provisions of the Ordinance during the prescribed period and classified as -

(a) Grade 1 milk -

(i) where such milk is not surplus to the Island's milk requirements, shall be, during each period specified in the first column of the Schedule to this Order, the price specified in relation to such period in the second column of that Schedule;

(ii) where such milk is surplus to the Island's milk requirements, shall be such reasonable commercial price as the Committee shall from time to time determine;

(b) Grade 2 milk, shall be one shilling.

3. The Milk (Wholesale Prices) (Guernsey) Order, 1968, is hereby revoked.

4. The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.

5. This Order may be cited as the Milk (Wholesale Prices) (Guernsey) Order, 1969, and shall come into force on the first day of July, nineteen hundred and sixty-nine.

The seventh day of December, nineteen hundred and sixty-nine, to the twenty-eighth day of February, nineteen hundred and seventy, both dates inclusive.	Three shillings, seven pence and three farthings.

The first day of March, nineteen hundred and seventy, to the twenty-first day of March, nineteen hundred and seventy, both dates inclusive.	Three shillings and one halfpenny.
The twenty-second day of March, nineteen hundred and seventy, to the second day of May, nineteen hundred and seventy, both dates inclusive.	Two shillings, seven pence and three farthings.
The third day of May, nineteen hundred and seventy, to the thirtieth day of May, nineteen hundred and seventy, both dates inclusive.	Two shillings and eight pence.
The thirty-first day of May, nineteen hundred and seventy, to the thirtieth day of June, nineteen hundred and seventy, both dates inclusive.	Two shillings and ten pence.
