The Parking Places Order, 1968

Made the 5th of February, 1968.

Coming into Operation on the 12th of February, 1968.

THE ISLAND POLICE COMMITTEE, in pursuance of the powers vested in it by section one of the Road Traffic (Parking Places) Ordinance, 1963, and of all other powers enabling it in that behalf, hereby orders:-

1. The areas and parts, set out in the third column of Part I of the First Schedule to this Order, of the public highways set out in the second column of that Schedule respectively opposite thereto are hereby designated disc parking places and are hereafter in this Order referred to by the numbers respectively assigned to them in the first column of that Part of that Schedule.
2. The areas and parts, set out in the third column of Part II and Part III of the First Schedule to this Order, of the public highways set out in the second column of that Schedule respectively opposite thereto are hereby designated approved parking places and are hereafter in this Order referred to by the numbers respectively assigned to them in the first column of those Parts of that Schedule.
3. A person, being in charge of a vehicle, shall not park that vehicle in any of the approved parking places set out in Part III of the First Schedule to this Order.
4. A person, being in charge of a motor bicycle, shall not park that motor bicycle in any of the disc parking places set out in Part I of the First Schedule to this Order.
5. A person -
 - (a) being in charge of a vehicle, shall not park that vehicle in disc parking places Nos. D7, D8 or D53, or
 - (b) being in charge of a motor bicycle, shall not park that motor bicycle in approved parking place No. MB5,when those parking places are being used, or are required for use, in connection with any vessel.
6. A person, being in charge of a public vehicle, shall not park that public vehicle in any disc parking place or approved parking place except when that vehicle is on hire to a passenger save that a person, being in charge of a public vehicle, may park that public vehicle in approved parking places Nos. A3, A4, A5, A6 or A7, for the purposes of standing or plying for hire.
7. A person who carries on the business of a dealer in or repairer of vehicles, or who carries on the business of letting vehicle on hire, shall not cause or permit any vehicle in his possession in the course of any such business as aforesaid, whether as owner, bailee or otherwise, to be parked in any disc parking place or any approved parking place, nor shall any servant or agent of his being in charge of any such vehicle cause or permit that vehicle to be so parked.

8. (1) A person, being in charge of a vehicle other than an omnibus, or being in charge of a motor bicycle, shall not park that vehicle or motor bicycle in approved parking place No. A1.
- (2) A person, being in charge of a vehicle or a motor bicycle, shall not park that vehicle or motor bicycle in approved parking place No. A2 except with the permission in writing of the Chief Officer.
- (3) A person, being in charge of a vehicle or a motor bicycle other than a public vehicle standing or plying for hire, shall not park that vehicle or motor bicycle in approved parking places Nos. A3, A4, A5, A6 or A7.
9. A person, being in charge of a vehicle, shall not, without the permission in writing of the Chief Officer, park that vehicle -
- (a) in disc parking place No. ~~D19~~ -
- (i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for any continuous period greater than a period of fifteen minutes, or
- (ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than a period of ten hours;
- (b) in disc parking places Nos. D14, D17, D18, D22, D28, and ~~D25~~ -
- (i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for any continuous period greater than a period of thirty minutes, or
- (ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than a period of ten hours;
- (c) in disc parking places Nos. ~~D2, D6, D16, D24 and D39~~ ^{D10, D13,} ~~D24, D39~~ ^{D24, D39,}
- (i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for a continuous period greater than a period of one hour, or
- (ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than a period of ten hours;
- (d) in disc parking places Nos. D3, D8, ~~D9, D15,~~ D23, D32, D33, D34, ~~and~~ D50.
- (i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for a continuous period greater than a period of two hours, or
- (ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than
- (e) in disc parking places Nos. D11, D26, D27, D31, D35, D36, D42, D46, D47, D48, ~~D51,~~ D52, D53 and D54 between the hours of midnight of any day and midnight of the day next following for any continuous period greater than a period of ten hours;

(f) in disc parking places Nos. D20 and D24 -

(i) during the hours in which the Public Markets are open for business save that a person, being in charge of a motor delivery vehicle, may park that motor delivery vehicle in either of these disc parking places for any continuous period not greater than a period of one hundred and twenty minutes during the said hours, or

(ii) during the hours in which the Public Markets are not open for business for any continuous period greater than a period of ten hours during the said hours;

(g) in disc parking places Nos. D1, D4, D5, D7, ^{D9}D12, D15, D25, D30, D37, D38, D40, D41, D43, D44, D45, and D49 -

(i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for a continuous period greater than a period of five hours, or

(ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for a continuous period greater than a period of ten hours.

10. A person, being in charge of a vehicle or a motor bicycle, shall not, without the permission in writing of the Chief Officer, park that vehicle or that motor bicycle in any of the approved parking places set out in Part II or Part III, as the case may be, of the First Schedule to this Order between the hours of midnight of any day and midnight of the day next following for any continuous period greater than a period of twenty-three hours.

14. A person, being in charge of a vehicle, who parks that vehicle in a disc parking place or an approved parking place in single line and behind or in front of, any other vehicle, that being the manner indicated in pursuance of the provisions of paragraph (a) of section twelve of this Order, shall park that vehicle as close as is reasonably practicable to the kerb or the edge of the carriageway as the case may be.
15. A person, being in charge of a vehicle or a motor bicycle, which is parked in a disc parking place or an approved parking place shall move that vehicle or motor bicycle, as the case may be, from that disc parking place or approved parking place or from any part of the disc parking place or approved parking place, as the case may be, to any other part thereof on the request of any person having reasonable grounds for making such request or at the request of a police officer.
16. In this Order the following expressions have the meanings hereby respectively assigned to them, that is to say:-
 - "Bank Holiday" means a day appointed as a Bank Holiday by Ordinance;
 - "the Chief Officer" means the Chief Officer of the salaried police force;
 - "motor delivery vehicle" means any vehicle which is designed or constructed for use wholly or mainly for the carriage of goods;
 - "parking sign" means a sign erected, placed or marked on or near a public highway by the Island Police Committee indicating the limits of a disc parking place or an approved parking place and the conditions upon which vehicles or motor bicycles may be parked therein;
 - "police officer" means a member of the salaried police force and, within the limit of his jurisdiction, a member of the special constabulary;
 - "public highway" includes any road, street, lane or public place;
 - "public vehicle" means a vehicle which is used for the carriage of passengers for hire or reward and which is offered for use either by standing or plying for hire or which is so offered in any other way whatsoever;
 - "vehicle" means a mechanically propelled vehicle intended or adapted for use on the public highway and includes a motor bicycle combination and a motor tricycle but does not include a motor bicycle.
17. Notwithstanding the preceding provisions of this Order, the Chief Officer may in his discretion, from time to time, close any disc parking place or approved parking place by exhibiting or causing to be exhibited thereon in such manner as to be clearly visible to a person intending to park a vehicle or a motor bicycle thereon a notice stating that the disc parking place or approved parking place, as the case may be, is closed and is not available for the parking of vehicles or motor bicycles and may in his discretion re-open such disc parking place or approved parking place by the removal of the said notice.
18. The Orders set out in the Second Schedule to this Order are hereby repealed.

19. This Order may be cited as the Parking Places Order, 1968.

20. This Order shall come into force on the twelfth day of February, nineteen hundred and sixty-eight.
